1 **A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY IN SUPPORT**  
2 **OF EFFORTS TO RESTORE THE EKLUTNA RIVER.**

4 **WHEREAS**, the Native Village of Eklutna is the largest Denai'na settlement in the  
5 Municipality of Anchorage; and  
6

7 **WHEREAS**, the Eklutna River historically was a major subsistence resource for the  
8 Eklutna People; and  
9

10 **WHEREAS**, the Eklutna River has been in a badly degraded condition since 1929  
11 due to hydropower dams and water diversions; and  
12

13 **WHEREAS**, the Eklutna River still supports five species of salmon, including Cook  
14 Inlet king salmon and sockeye salmon, though in [**greatly**] diminished numbers from  
15 historical levels; and  
16

17 **WHEREAS**, Eklutna Incorporated, the village corporation for Eklutna, is the largest  
18 landowner in the Municipality of Anchorage and owns most of the land along the  
19 Eklutna River and around Eklutna Lake; and  
20

21 **WHEREAS**, Eklutna Inc., and the Eklutna people have made substantial  
22 contributions to the development of the Municipality of Anchorage through school  
23 sites, highways, **parks**, railroads, **housing**, powerlines and rights-of-way; and  
24

25 **WHEREAS**, The Conservation Fund and Eklutna Inc., are collaborating on a  
26 \$7.5 million project to dismantle the Lower Eklutna River dam; and  
27

28 **WHEREAS**, Little to no water flows out of Eklutna Lake into the Eklutna River  
29 because of water diversions for the Eklutna Power Project **and the supply of**  
30 **approximately 86 percent of the drinking water for Anchorage and Eagle River;**

33 **WHEREAS**, Municipal Light and Power (ML&P), **Chugach Electric Association,**  
34 **and Matanuska Electric Association (collectively the "Eklutna Power**  
35 **Purchasers") jointly own and operate the Eklutna Power Project [owns a 52%**  
36 **share of the Eklutna Power Project];** and

WHEREAS, The Eklutna Power Project often provides the least expensive renewable power on the Railbelt; and

WHEREAS, The Eklutna Power Purchasers are contractually obligated to study and develop a proposed Fish and Wildlife program to address ~~ML&P is legally obligated to mitigate for~~ the impacts of the Eklutna Power Project to fish and wildlife, pursuant to the 1991 Fish & Wildlife agreement; and

WHEREAS, Mayor Ethan Berkowitz and members of the Anchorage Assembly have frequently expressed their support for wild salmon and Anchorage's desire to be a "Salmon City;" now, therefore

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. The Assembly recognizes the contribution of the Eklutna people and Eklutna Inc. to the development of the Municipality of Anchorage and supports the efforts to restore the hydrology and fisheries of the Eklutna River subject to all provisions of the Fish & Wildlife agreement of August 7, 1991.

Section 2. The Assembly urges the Eklutna Power Purchasers to initiate a consultation process, as defined in the 1991 agreement, [Municipal Light and Power] to begin necessary studies early to examine [define] the impacts to fish and wildlife of Eklutna Lake and Eklutna River hydropower operations [and to begin collaborative efforts to restore water flows to the Eklutna River].

Section 3. This resolution shall be effective upon passage and approval.
